4. **REGISTRATION FEE:** I agree to pay the **registration fee of \$25.00** upon registering my child. This fee is non-refundable.

5. **ABSENTEEISM:** I understand that I will receive no reduction in fees for days that my child is absent due to illness, vacation or for other reasons. Every absence must be phoned in.

6. **TERMINATION NOTICE:** I understand and agree that I must provide **two weeks written notice**, prior to the withdrawal of my child.

7. A charge of \$25.00 will apply to all NSF cheques or returned cheques. After two returned

cheques you will be required to make your child's payments in cash, certified cheque or money order.
